#### Personal Information Collection Statement 個人資料收集聲明

ZA International Insurance Broker Limited ("ZA Broker"/ "We") is committed to the protection of privacy in relation to personal information. ZA Broker collects, uses and retains your personal information in accordance with the Data Protection Principles and all relevant provisions of the Personal Data (Privacy) Ordinance (the "Ordinance").

# 1) Personal information we collect and/or hold 我們收集及/或持有的個人資料

Your personal information that we collect and/or hold, we believe to be relevant for us to understand your financial needs as well as to provide our service to you.

Broadly, we collect personal data (such as your name, identity card number, date of birth, correspondence address, phone number, email address, identification document image, facial image, employment information, address and income proof images etc.), supplied by you to us from time to time in connection with matters and purposes set out in paragraph 3.

# 2) Importance of personal information collection 收集個人資料的重要性

The provision of your personal information is on a voluntary basis; however, if you do not provide sufficient information, we may not be able to provide service to you.

#### 3) Usage of personal information 個人資料的用途

Your personal information held by ZA Broker may be used for the following purposes:-

#### 4) Information confidentiality 資料保密

Your personal information held by ZA Broker will be kept confidential. But for the purpose of providing service to you as set out in paragraph 3, we may provide, transfer or disclose your personal information to any one or more of the following parties (whether within or outside Hong Kong):

- (g) any financial institution and merchant acquiring company with which you have or propose to have dealings; 與閣下或擬與閣下進行交易的任何金融機構及收購公司的商戶;
- (h) any actual or proposed assignee of all or any part of our business and/or asset or participant or subparticipant or transferee of our rights in respect of you; 我們的全部或任何部分業務及/或資產的任何實際或潛在受讓人,或我們對閣下的權利的參與者或次級參與者或受讓人;
- (i) any party giving or proposing to give a guarantee or third-party security to guarantee or secure your obligations; 任何一方就 擔保或確保閣下的義務而給予或建議提供擔保或第三方擔保;
- (j) any interface (such as an application programming interface) that links to, or in any way makes available information about our Financial Services and/or Financial Products; 連接或以任何方式提供有關我們的理財服務及/或理財產品的資料的任何界面(例如應用程序編程界面);
- (k) any member of the ZhongAn Group acting as a data controller in respect of your data; 眾安集團的任何成員公司就閣下的資料擔任資料監管人;
- (I) third party financial institutions, insurers, credit card companies, securities and investment services providers; 第三方金融機構、保險公司、信用卡公司、證券及投資服務供應商;
- (m) third party reward, loyalty, co-branding and privileges programme providers; 第三方獎勵、忠誠、聯乘品牌及優惠計劃供應商;
- (n) our co-branding partners and/or co-branding partners of any member of the ZhongAn Group (the names of such co-branding partners can be found in the application form(s) for the relevant services and products, as the case may be); 我們的聯乘品牌合作夥伴及/或眾安集團任何成員公司的聯乘品牌合作夥伴(此等聯乘品牌合作夥伴的名稱可在相關服務及產品的申請表中找到(視情況而定);
- (o) charitable or non-profit making organisations; and/or 慈善或非牟利機構;及/或

### 5) Transfer of information outside Hong Kong 轉移資料往香港以外地區

ZA Broker may from time to time transfer your personal information outside Hong Kong for different purposes including processing or storage.

### 6) Data Access 資料查閱
